## Fleet Consolidation Diversity is Key to Sustainability

Fleet consolidation can take on many forms - concentration of ownership, reduction in number of active vessels, fewer ports where fish are landed, fewer gear types, and a narrower scale of vessel size/capacities serve just to name a few. Consolidation also takes place in the quota leasing market.

We know from other areas of the economy that unchecked consolidation can have disastrous consequences. For example, consolidation in our land-based food system resulted in displacing family farmers, degrading our lands, and reducing the quality of our food.

Like with our farmers, we believe that 'Who Fishes' has enormous ecological, social/economic, and food-system significance. Therefore, we need to get the facts on where consolidation is heading us and ensure we do not repeat past mistakes.

## What we want:

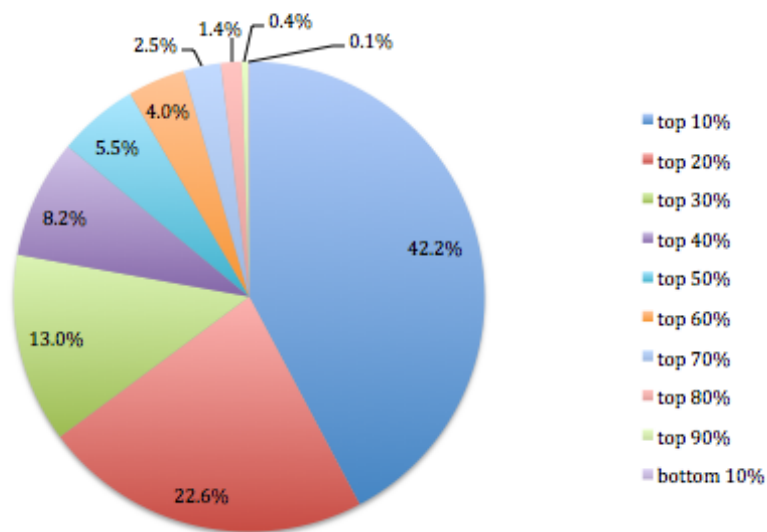
- Policies that safeguard a more diverse fleet including different gear types, boat sizes, and geographic locations.
- Limit the concentration of quota for any one entity.
- Establish policies that ensure quota is fished by fisherman and not used solely as an investment tool.
- Institute quota set-aside programs to reward sectors that are able to meet certain benchmarks in order to promote fleet diversity.
- Establish mechanisms to keep offshore boats offshore for example restrictions from fishing in multiple broad stock areas.
- Establish leasing and permit trading constraints that maintain affordability for smaller fishing operations and new entrants.



## How we are achieving this:

- For the past three years NAMA and the Fish locally Collaborative have been weighing-in to fisheries managers to keep amendment 18 on the table and ensure community based fishermen are at the forefront of guiding the policies forward.
- Through the Think Global; Eat Local Seafood mantra, NAMA is building a market for the catch of ecologically responsible, local fisheries that will allow us to build a base of support for the long-term health of the marine ecosystems that sustain the economic health of small-scale fishing communities.
